# JAMIE

Consistent, caring therapy at CCI transformed Jamie's complex mental health challenges, including anxiety, depression, suicidal thoughts, and Pica. Over two years, her counselor offered steady guidance, fostering healthy coping skills. Identifying a sensory link to her Pica led to occupational therapy, revealing triggers and safe alternatives.

This dedicated support built a strong therapeutic bond, significantly reduced Jamie's self-harm ideation, and managed her Pica. Now equipped with coping skills, Jamie feels hopeful about her future, demonstrating the profound impact of integrated, compassionate mental health care.

# CARRIE

Carrie, a single mother, found a steadfast ally and comprehensive support at CCI through a dedicated case manager. Consistent sessions provided essential case management and empathetic parenting education, offered community resources, helped with budgeting, and encouraged healthy relationships.

This holistic approach equipped Carrie with practical parenting skills, newborn care education, postpartum well-being strategies, and self-care techniques. Essential newborn items and diaper bank connections offered tangible support.

# Programs



## Social Services

Our team of case managers are trained to help those most vulnerable in our community. We work one on one with participants in our social services program to achieve their financial, physical, and spiritual goals through strength-based planning and intensive case management. Our services include several long-term subsidized housing programs for low-income seniors, single parent households, and migrant families. For individuals who may not qualify for our rent-assistance programs, we are proud to connect them to other helpful agencies, provide parenting education, and supply urgent need items.

## Faith-Based Counseling

Our licensed, professional counselors serve individuals, families, and couples to address a range of needs, including depression, trauma, anxiety, stress, compulsive behaviors, grief/loss, marriage, and family relationship challenges. Our high-quality services integrate sound psychological training and principles along with spiritual direction in a manner consistent with Catholic Social Teachings. Our staff bring compassion and diverse clinical experience to the services we offer!



# Immigration Legal Services

We offer professional, low-cost immigration services provided by our Department of Justice recognized staff. Services include comprehensive immigration assessments and expert legal representation for a broad range of immigration matters, including religious visas for priests serving in our Diocese, citizenship applications, family petitions, green card applications and renewals, work permits for immigrants who came to the US when they were children, and victims of crime. We are passionate about our work and love the people we serve here in Idaho!

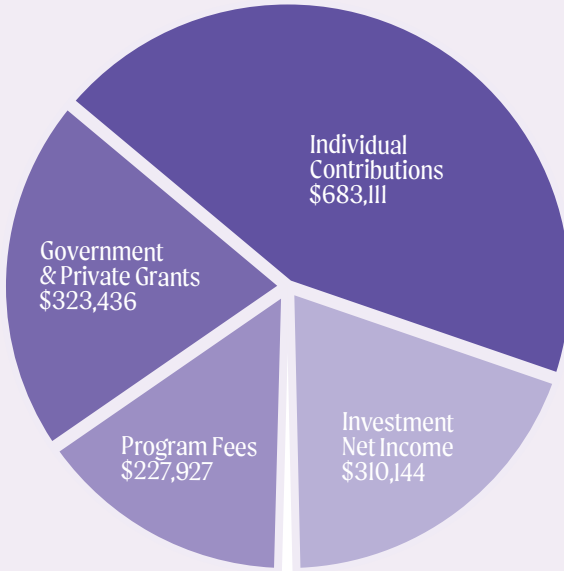

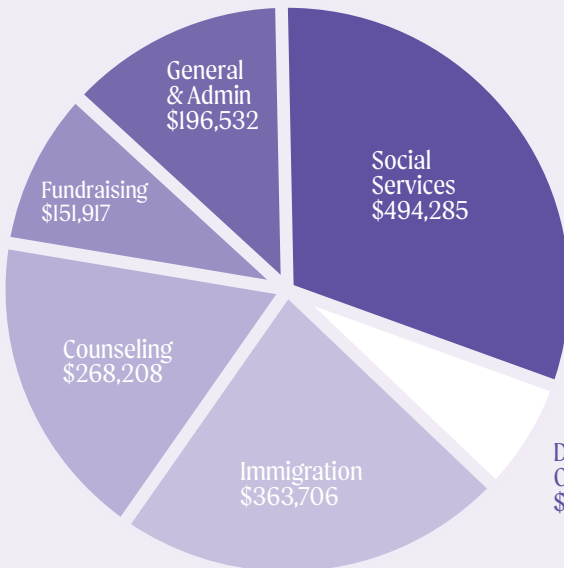
